Mayor Lane: Okay. Thank you for that. I would like to start to just make a note of a few things as we conduct our council meeting virtually. Number one, our bullet point one if you will, make sure that you are in a quiet space with no -- no to minimal background noise and please mute yourself and that is the lower left-hand corner of the Zoom window. Moving on to just a report for the day. On April 29<sup>th</sup>, 1980, 40 years ago, for make a wish day here in Scottsdale, which is being proclaimed right now, the 40<sup>th</sup> anniversary, but at that time a 7-year-old Scottsdale boy named Chris gracious had a wish. He loved the TV show "Chips" and wanted to be a police officer when he grew up. He was also being treated with cancer -- for cancer at a local hospital. A family friend was a U.S. Customs detective who partnered with the Arizona department of public safety to grant the wish. Chris rode in a police helicopter to D.P.S. headquarters where he and his mother got a V.I.P. tour.

He received the D.P.S. badge and was made the first honorary D.P.S. officer by the agency. By the end of the day, the boy had a smoky the bear hat, a D. P.S. badge that made him a real D.P.S. honorary officer. He even received a custom uniform.

Chris gracious passed away shortly after that, but his life had a lasting effect -- his life had a lasting effect on Scottsdale, the state of Arizona and the world. The officer and the mom, Linda Pauling, founded a nonprofit organization called make-a-wish. They created life-changing wishes for children with critical illnesses. They had granted more than 300,000 life wishes for children all over the world, and it started right here in Scottsdale.

Earlier today, as you may see, if you are capable of getting the video, you will see some pictures of make-a-wish, and 78<sup>th</sup> street is make-a-wish way and I proclaim this as make a wish day. They create life-changing wishes for children with critical illnesses.

Congratulations to make-a-wish and Arizona and -- and wish them another 40 years and beyond in their -- in their great work.

The Tourism Development Commission advises the City Council on matters concerning the expenditure of revenues from the Transaction Privilege Tax on transient lodging (bed tax) designated for tourism development.

Special Qualifications: As specified in the Scottsdale City Code, the Tourism Development Commission shall consist of representatives of the tourism industry in Scottsdale, including a minimum of four Scottsdale hoteliers, one member of the Scottsdale Convention and Visitors Bureau, and a balance from elements of the tourism industry.

David Winter resigned from the commission in June. He represented a hotelier position. Ken McKenzie's term has expired. He is eligible for reappointment and has submitted an application for consideration. He represents a hotelier position. There are two hotelier position

vacancies and four applications on file.

So I just want clarification. I believe these appointments have to be hotelier applicants. Can someone clarify that for me?

City Attorney Sherry Scott: Yes, this is Sherry Scott. These two vacancies are both hotelier vacancies so they both have to be hoteliers.

Vice Mayor Whitehead: Okay. So it looks like we have two hotelier applications, which are Ken McKenzie and Michael Recuber. The other industry applicants don't qualify as hoteliers, but they are Monica Nicodemus, and Krista Welch.

Councilmember Korte: Excuse me, Vice Mayor. Can someone talk about the note on the applicants that McKenzie seems to be the only one affiliated with Scottsdale hotel resort? Can someone talk about the Michael Recuber issue here?

Management Assistant Rommel Cordova: Vice Mayor, Councilmember Korte, this is Rommel. The two applications that you did get that got submitted, both applicants noted themselves as being hoteliers.

Mr. Recuber, I believe, he also noted himself as being an industry representative, or having that experience, but you are correct, he did not in his application indicate any affiliation with the Scottsdale hotel or resort.

Councilmember Korte: Okay. Can I then summarize that Recuber is not -- does not fit the -- the application protocol here?

City Attorney Sherry Scott: This is Sherry Scott. [Garbled audio] This applicant would meet the -- the required hotelier.

Vice Mayor Whitehead: So what is the best way to proceed here?

City Attorney Sherry Scott: [Garbled audio] Whether or not someone qualifies for that position and it will be up to the council to make that determination. So I think that the council should proceed with the nominations on the basis of the information presented and the applications.

Vice Mayor Whitehead: I have an additional question. States there are two hotelier openings and two candidates who have submitted for that position. But here in my notes, it says that

each councilmember nominates one. Is there some clarification there?

City Attorney Sherry Scott: It would be my understanding that -- that council would be -- [ Garbled audio ]

Vice Mayor Whitehead: Okay. So -- so I suppose we could vote for up to two, one or two because of some concern about qualifications. Is there April action -- do we double check if we want to appoint someone, that the qualification is not met, is there some sort of action to make sure that we have the commission appointees appropriately qualified?

City Attorney Sherry Scott: This is Sherry Scott. Vice Mayor, what -- what we would normally do, if a councilmember wanted to appoint an applicant where it wasn't completely clear whether they qualified, is to seek additional information from them about their qualifications before the appointment.

Vice Mayor Whitehead: Okay. Well, I see. And I somehow did not catch that okay. Well, I will --

Mayor Lane: Just a point to try to clarify, I guess. Mr. Recuber has got on his application two locations in Nevada, where he was in that business in the hotel business. My question would simply be, a hotelier, is he or she only defined by being involved with a hotel in Scottsdale or certainly that is included within our experience Scottsdale group of hoteliers in the P.V. and Scottsdale area? Can it be experience from some other named location?

City Attorney Sherry Scott: Mayor, again, this is Sherry Scott. I don't believe our ordinance really defines exactly what that would be and it would be up to the council to determine that.

So I do believe that there would be some discretion if the council chose to do so to consider someone with past experience from a hotel in another location a hotelier. I think the intent may have been Scottsdale hoteliers, but, again, it's -- it's the council's ordinance, and the council's determination.

Mayor Lane: Just for the record, we name people with other experience in hotels with the experience Scottsdale scope of vision as far as this marketing is concerned from Phoenix and P.V., and I'm not sure at this present time, whether there's any on the -- and I think we have actually from the tribe as well.

So to me, it seems clearer, if he indicates that he is a hotelier and he gives experience as he does in his application, but I -- I guess I wouldn't want to have anybody decide that they can't nominate him. If he's not nominated by someone else, I will nominate him. You know, if we want to do some further research. I think he probably does qualify.

City Attorney Sherry Scott: This is Sherry Scott. I'm reading the ordinance to double check myself and I'm glad I did. It does say Scottsdale hoteliers.

Mayor Lane: So a hotelier that works and has experience on tribal lands does not qualify?

City Attorney Sherry Scott: It says Scottsdale hoteliers.

Mayor Lane: Okay. Well, then he doesn't qualify.

City Attorney Sherry Scott: Then again, it's up to the council to determine what would meet that definition as long as it's a reasonable definition of a Scottsdale hotelier. I don't have the applications in front of me. I don't have that information to review to help you any further.

Mayor Lane: Okay. I guess we could go through the process with that information. Okay. Thank you. And thank you Vice Mayor.

Vice Mayor Whitehead: Okay. So let's go ahead and get these nominations going. I think I'm at Councilwoman Klapp.

Councilwoman Klapp: Ken McKenzie.

Vice Mayor Whitehead: Mayor Lane?

Mayor Lane: I'm sorry, did you call me?

Vice Mayor Whitehead: Yes, Mayor Lane?

Mayor Lane: Michael Recuber.

City Attorney Sherry Scott: Vice Mayor, again, this is Sherry Scott. The council can proceed with their nominations on this item, just as they would any other nomination that they do for any other commission or board. The only thing that staff was trying to point out to council is there is a concern about whether or not some applicants qualify as a hotelier.

Vice Mayor Whitehead: Okay. Since these are just nominations, I will continue and see if others get nominated. Councilmember Korte.

Councilmember Korte: No additional.

Vice Mayor Whitehead: Councilmember Phillips.

Councilmember Phillips: Monica Nicodemus and Christa Welch.
