– Vice Mayor Littlefield made a motion to continue the City Attorney's contract at a base salary of \$304,000 to be effective and retroactive to the beginning of the June 18, 2023 pay period. Mayor Ortega second the motion, which carried 7/0, with Mayor Ortega; Vice Mayor Littlefield; and Councilmembers Caputi, Durham, Graham, Janik, and Whitehead voting in the affirmative.

- Vice Mayor Littlefield made a motion to continue the City Treasurer's contract at a base salary of \$242,000 to be effective and retroactive to the beginning of the June 18, 2023 pay period. Councilwoman Whitehead seconded the motion, which carried 7/0, with Mayor Ortega; Vice Mayor Littlefield; and Councilmembers Caputi, Durham, Graham, Janik, and Whitehead voting in the affirmative.

- Vice Mayor Littlefield made a motion to continue the City Clerk's contract at a base salary of \$200,000 to be effective and retroactive to the beginning of the June 18, 2023 pay period. Councilwoman Janik seconded the motion, which carried 7/0, with Mayor Ortega; Vice Mayor Littlefield; and Councilmembers Caputi, Durham, Graham, Janik, and Whitehead voting in the affirmative.

- Councilmember Durham made a motion noting that the Acting City Manager has been retained under a third-party employment contract which expires October 13, 2023. Accordingly, the City Council directs the Human Resources Department to explore options for the recruitment of a Charter City Manager and to report back to the City Council. Councilwoman Whitehead seconded the motion, which carried 6/1, with Mayor Ortega; Vice Mayor Littlefield; and Councilmembers Durham, Graham, Janik, and Whitehead voting in the affirmative and Councilwoman Caputi dissenting.
