Mayor's Report

- Mayor Ortega called attention to the ongoing wars in foreign countries as they fight to protect their democracy and freedom and asked for a moment of silent reflection for these war-torn countries.
- Mayor Ortega presented a proclamation declaring Volunteer Week in Scottsdale and noted that Scottsdale has over 3,700 volunteers. The proclamation was presented to the City's Volunteer Coordinator, Bryan Chapman.
- Mayor Ortega encouraged residents to apply to serve on a Board or Commission and highlighted the Board of Adjustment, Historic Preservation Commission, and Loss Trust Fund Board. There are currently 12 Boards and Commissions that have openings and applications will be accepted until April 26.
- Mayor Ortega announced the Tour de Scottsdale at WestWorld was a success and thanked staff for making the event possible. He noted that Vice Mayor Solange Whitehead, Water Resources Executive Director Brian Biesemeyer, and the seven-member Water Services team completed the 62-mile trek.

Presentations/Information Updates – Scottsdale Arts President and Chief Executive Officer Gerd Wuestemann gave a PowerPoint presentation on Scottsdale Arts.

- City Treasurer Sonia Andrews, Acting Budget Director Ana Lia Johnson, Water Resources
 Executive Director Brian Biesemeyer, and City Engineer Alison Tymkiw gave a PowerPoint presentation on the proposed Fiscal Year (FY) 2024/25 Operating Budget and Capital Improvement Plan.
- Mayor Ortega opened public comment on this item.
- Robert Lettieri provided suggestions about possible changes to the budget documentation to promote transparency and clarity for the public.
- Mayor Ortega closed public comment on this item.
- There was Council consensus on the following item:
 - Move forward with the proposed FY 2024/25 Operating Budget and Capital Improvement Plan.
- Councilmembers made the following observations and suggestions:
 - Drainage and transportation projects and water and sewer projects often are put forward in tandem.
 - The Greenway Hayden Loop Sewer Improvements cost will be recouped through development agreements as various developments move forward.
 - The Pima Road construction project from Happy Valley Road to Jomax Road should have an intermittent construction break to address resident concerns.
 - Staff should research the contingency fund policies of other municipalities and report back to the City Council with their findings.
 - To simplify the budgeting process, consider putting the \$10 million in funding set aside for the Class and Compensation Study in either the merit adjustment or market adjustment line items.
 - An additional 60 employees are requested in the FY 24/25 budget mainly due to the new Ambulance Service and new Fire Station.
 - Population growth and employee level growth should be kept at a similar pace.
 - The Residence at Paiute budget line should be removed.
 - It is beneficial that the Shade Study is moving forward.
 - There are many positive recreational facility improvements in the budget, especially for McCormick Stillman Railroad Park and Scottsdale Stadium.
 - To maintain the City's motto of "Simply Better Service", it is important to ensure employees are sufficiently compensated and the city has the necessary number of employees to keep up with needed service levels.
 - Scottsdale is a donor city to the state because Scottsdale produces significant tax revenue, but
 it does not all come back to the city for use since the city has a significant number of
 "snowbirds" and tourists, who are not included in our population estimates.
 - The budget is influenced by resident input, such as sidewalk segment that is being added in South Scottsdale.
 - The State has cut the city's tax revenues by \$20 million to \$30 million, and it is extremely difficult to make up that deficit using General Fund revenues.
 - The City produces many critical services such as water and public safety, and many other services that may not always be recognized, such as graffiti removal.
 - Additional road lanes and road widening projects are under construction.
 - Mayor and Council discretionary funds should be used for affordable housing and/or sustainability projects.
 - While the overall budget was reduced from 9.5% from a year ago, the city is Increasing law enforcement technology, tools, and facilities needed by our public safety departments
 - \$15 million was allocated to affordable housing.
 - The budget was reduced and is at 97% of the expenditure limitation capacity.

***19. <u>Amend the Rules of Council Procedure Related to the Use of Technological Devices During</u>
Public Meetings

Request: Amend the Rules of Council Procedure, Rule No. 5.11, related to the use of technological devices during public meetings and/or direct staff regarding additional measures that may further mitigate concerns related to the use of technological devices to send or receive communications during public meetings.

- City Attorney Sherry Scott gave a PowerPoint presentation on possibly amending the Rules of Council Procedure related to the use of technological devices during public meetings.
- Mayor Ortega made a motion to amend the Rules of Council Procedure, Rule No. 5.11 as presented by staff:
- Councilmembers shall not send any electronic communications while attending public Council Meetings or Executive Sessions. Only electronic devices supplied by the City and approved for use during Council Meetings may be used during the Council Meetings for noncommunicative purposes, such as referencing Meeting materials. All other electronic devices must be stored elsewhere during Council Meetings.
- 2. Establish an emergency contact line that is monitored during Council Meetings in case a councilmember needs to be called away from the meeting for a personal reason.

 Councilwoman Caputi seconded the motion, which carried 7/0, with Mayor Ortega; Vice Mayor Whitehead; and Councilmembers Caputi, Durham, Graham, Janik, and Littlefield voting in the affirmative.

- Mayor Ortega opened public comment on this item.
- French Thompson spoke about the parking locations identified in the Bond 2019 projects and the parking needs south of Indian School Road. Sonnie Kirtley, representing the Coalition of

Greater Scottsdale (COGS), noted that parking needs have changed over the years and COGS supports adding two levels to the garage where the farmers market is held and finding parking resources for the northeast quadrant. Bob Pejman opposed additional parking in the northeast quadrant and stated the Bond 2019 projects and ballot language created a reasonable expectation for where voters could expect the parking to be added, which the Council should honor. Jon Rosenberg said the northeast quadrant needs additional daytime parking and the lack of parking is impacting businesses and future development in the area. Danielle Larkin spoke about the difficulty of finding parking for both employees and clients and how it has impacted her business on Stetson Drive located in the northeast quadrant.

1. Downtown Parking Update

Request: Presentation, discussion, and possible direction to staff regarding downtown parking.

- Public Works Director Dan Worth gave a PowerPoint presentation on possible Downtown Parking options.
- There was Council consensus on the following items:
 - There are areas in downtown that need parking, both north and south of Indian School Road.
 - Additional signage is needed to help locate parking garages.
- Councilmembers made the following observations and suggestions:
 - Over the last several decades, considerable funding has been spent studying the parking issue and a solution needs to be determined that considers the entire downtown area.
 - Additional parking for the northeast quadrant has not been addressed and additional parking is needed for this area, especially during the daytime.
 - The Bond 2019 ballot language gave parking options that were being considered, but also indicated the City would continue to explore other locations for possible parking.
 - The Galleria should not be considered as a possible solution as it is privately owned and the City cannot require the owner to provide additional parking.
 - The P-2 and P-3 parking overlay district were created in the 1980s and was the only way for small lots to be developed. However, this area has grown over time and there is not enough available parking.
 - More parking is needed if older lots are going to be redeveloped.
 - The Stetson was deeded to the City to build additional parking.
 - There are ridesharing and shuttle options for major events in Old Town.
 - The Civic Center will have more events but that does not necessarily mean there is a need for additional parking capacity as events likely will not overlap.
 - There are sufficient parking options in and around the 1st Street and Brown Avenue Parking Corral.
 - An alternative option to the two listed by staff would be to continue with the Artisan parking and add parking at the Stetson Drive/6th Avenue location (ground floor plus one floor above), which would bring the project in under budget.
 - Parking should be added based on need and data analysis.
 - Multiple events held at the same time does not necessarily mean the number of parking spaces has to be increased at the same rate as individuals attend events at different times.
 - There is much garage space that is not utilized during the day.
 - More information is needed to see how the garages are used and where are the peak demands for parking space.

- The Bond 2019 program gave voters a reasonable expectation of where parking would be located.
- The two additional floors option for the 1st Street and Brown Avenue Parking Corral option would provide a favorable economy of scale and should be pursued.
- The parking arrangement with HonorHealth is temporary and may not always be available and staff should research if there is a way to get some of the land back for parking.
- Bond 2019 funding should not be spent on the northeast quadrant.
- Staff should pursue Option #2, which involves additional parking at 1st Street and Brown Avenue, Stetson Drive and 6th Avenue, and the Artisan.
- There have been improvement districts over the years that have provided additional parking.
- The is not the only opportunity to add parking.
- Voters expect parking to be added in the Arts District.
- Maintaining the charm of Old Town is important and adding a large parking garage at 1st Street and Brown Avenue as presented would not add to the aesthetic and may cause issues with the Farmers Market.
- Staff should look at additional parking options in the HonorHealth area.
- If a business meets the parking requirements in the City Code, they can charge for additional offered parking.
- Adding one more level to the parking garage 1st Street and Brown Avenue would add shade for the Farmers Market.
- This discussion related to downtown parking options will continue at future council meetings.
