

ORDINANCE NO. 3849

AN ORDINANCE OF THE COUNCIL OF THE CITY OF SCOTTSDALE, MARICOPA COUNTY, ARIZONA, AMENDING CHAPTER 24 OF THE SCOTTSDALE REVISED CODE, SOLID WASTE MANAGEMENT AND CHAPTER 49 OF THE SCOTTSDALE REVISED CODE, WATER, SEWERS, AND SEWAGE DISPOSAL.

The City of Scottsdale must continue to accommodate community needs for service, without decreasing current standards of public health; and

The City desires to reflect the current costs to provide water and sewer facilities in the City of Scottsdale to meet present and increasing demand and recover costs using a fair and proportionate structure.

BE IT ORDAINED by the Council of the City of Scottsdale as follows:

Section 1.

Chapter 24 of the Scottsdale Revised Code, relating to solid waste management is amended by amending the following:

Section 24-29	Assessment of late charges,
Section 24-30	Administrative account establishment fee,
Section 24-31	Service charges, residential refuse and recycling generators.
Section 24-32	Service charges, commercial generators.
Section 24-33	Service charges, commercial roll-off service.

as provided in that certain document known as the "Amendments to Solid Waste Management Rates and Fees—Chapter 24, Scottsdale Revised Code" three copies of which are on file in the Office of the Clerk of the City of Scottsdale, Arizona, which document was made a public record by Resolution No. 7945 of the City of Scottsdale, Arizona, and is referred to, adopted, and made a part of this Ordinance as if fully set out in this Ordinance.

Section 2.

Chapter 49 of the Scottsdale Revised Code, relating to water, sewers, and waste disposal is amended by amending the following:

Section 49-22.1	Administrative account establishment fee.
Section 49-27	After hours service, generally.
Section 49-48	Metered domestic rates.
Section 49-50	Bulk water rates.
Section 49-51	Limitation on recovery.
Section 49-53.1	Assessment of late fees.
Section 49-54	Termination of service for nonpayment; fee; hearing.
Section 49-141	Rates and user charges.
Section 49-142	Administrative account establishment fee.
Section 49-145	Limitation on recovery.
Section 49-146	Assessment of late charges.
Section 49-252	Right to hearing.

as provided in that certain document known as the "Amendments to Water and Sewer Rates and Fees—Chapter 49, Scottsdale Revised Code", three copies of which are on file in the Office of the Clerk of the City of Scottsdale, Arizona, which document was made a public record by Resolution No. 7945 of the City of Scottsdale, Arizona, and is referred to, adopted, and made a part of this ordinance as if fully set out in this ordinance.

Section 3. If any section, subsection, sentence, clause, phrase or portion of this ordinance or any part of the code is for any reason held to be invalid or unconstitutional by the decision of any court of competent jurisdiction, that decision shall not affect the validity of the remaining portions of this ordinance.

Section 4. The effective date of this ordinance, as it relates to the amendments to Scottsdale Revised Code, is as follows:

- a. Sections 24-29, 24-30, 24-31, 24-32, 24-33 and 49-22.1, 49-27, 49-51, 49-53.1, 49-54, 49-141, 49-142, 49-145, 49-146, 49-252 are effective July 1, 2009.


Section 5. The effective date of this ordinance, as it relates to the amendments to Scottsdale Revised Code, is as follows:

- a. Sections 49-48 and 49-50 are effective November 1, 2009.


