VOLLEYBALL LEAGUE NOTES



- ✓ **Teams** must have the following minimums for games: 4-person must have two (2) players for each game, all 2-person teams must have two (2) players for each game and all COED 2's must have minimum of two (2) players with EITHER one (1) male & one (1) female OR two (2) females on the court at all times.
- ✓ **Teams** that wish to play in multiple Flights on the same night must have at least a **50% different** make-up for each flight.
- ✓ **Teams** who have never played in the sand volleyball league ***MUST ATTEND*** practice night games. This will ensure that the team is placed within the appropriate level of play.
- ✓ **Forfeit** procedure will be taken into affect when a team has ***more than 2*** nights that they forfeit. Under the discretion of the Volleyball Coordinator and Site Supervisor, your team may be placed on the waitlist for the next season. Only if there are spots available at the end of registration will your team be able to register.
- ✓ **Match times** listed (7 pm and 8:45 pm) are **START TIMES**, not the show-up times! Matches will ***start on time***. Courts will be called out **5** minutes before the start time. Forfeit time is **10-minutes** after scheduled match time. Whether both teams are present or not, if the match has not started by the **10-minute** forfeit time the result of the match will constitute a ***DOUBLE FORFEIT***. Courts are booked starting at 6pm each evening of league; please use this time to warm up. **During the Winter Season only, all matches will be played at 7pm.**
- ✓ **Tuesday Night teams are responsible to help with the set up and removal of the short court lines.** The 7pm games need to set up the lines, and the 8:45pm games need to take the lines down when finished. Please allow for extra time to help this process. ***The site supervisor is not solely responsible for setting up and taking down the lines.***
- ✓ **Games** will be played to 15 rally-scoring on Monday nights and to 25 rally-scoring on Tuesday nights with a cap at 30 for Tournaments. Both nights and scoring formats are considered win by two unless noted.
- ✓ **Adjacent courts** may be crossed into for returning a ball only when the adjacent court is not occupied.
- ✓ **Site supervisor** has the final call on any match play discrepancies.
- ✓ **Schedules** will reflect the number of teams in each Flight, not a specified number of weeks/games. Scheduling will be done to best suit the skill level of the teams and take into consideration time slots and courts available. A two week double elimination tournament will be played after the regular season ends.
- ✓ **Any team(s)** wishing to play in more than one (1) flight in the same night, at some time, may have to decide to play in one match over another. ***Example:*** Flight I schedule conflicts with Flight II schedule (or tournament game), the team will have to decide which game to play. Every effort will be made to avoid this, but it still may occur.
- ✓ **FOUL LANGUAGE OR INAPPROPRIATE BEHAVIOR** will not be tolerated. This is a family park, with others than the volleyball program participants using the areas. The following is an excerpt from the **City's Park Behavior Policy (and may be requested at any time):**

SANCTIONS FOR VIOLATING PARK BEHAVIOR POLICY

When there are reasonable grounds to believe that there has been a violation of the park behavior policy, park staff will take appropriate action and document the incident. Appropriate action may include requesting compliance of park ordinance or rules, working with parents of disruptive youth, conflict resolution that may involve other city staff, police notification, or formal sanctions. Formal sanctions include, but are not limited to, documented oral reprimands, written reprimands, suspension from a park program or activity, or suspension from a certain park or all parks for a specified period of time.

Etiquette

- ✓ **Any team** not able to make a scheduled match must contact the Scottsdale Ranch Park front desk by calling 480-312-7774 as well as their opponents. Failure to do so will result in an unexcused forfeit.
- ✓ **Please!! Do not smoke in the area of the volleyball courts. If smoking is necessary please step out to the parking lot.**

Final league and division assignments will be determined by the league coordinator and will depend upon the number of teams and their overall skill level. The league coordinator will make final decisions or changes to the schedule if needed.

Reminder: Teams dropping after the first week of league play will forfeit all league fees. Teams dropping ***prior to the first week*** of league play will receive a credit on their account, and a \$7 administration processing fee will be deducted from the credit amount.

Flights with an uneven number of teams will be assigned a BYE during the season. BYEs will be randomly assigned unless teams make a request. Requests must be submitted one week prior to the start of the league. No BYEs are guaranteed, however the best effort will be made to accommodate all requests.
