Description: The General Plan Task 2014 Force was established to: 1) create and deliver a recommended draft General Plan to the Scottsdale Planning Commission and City Council; 2) review and consider contents of the 2001 General Plan and non-ratified 2011 General Plan, as well as any past community input on the General Plan, in the General Plan 2014 draft; 3) work with the Planning Agency to host and/or attend community meetings for public input on the General Plan 2014; and 4) monitor progress and changes to the recommended Scottsdale General Plan 2014 before Council adoption. The General Plan Task Force (formerly called the General Plan 2014 Task Force), established by the City Council on July 2, 2014, creates and recommends a draft General Plan to the Scottsdale Planning Commission and City Council. The Task Force will use the 2001 General Plan as a starting point to create the new General Plan document, and they will consider all past and present community input as well as aspects of the non-ratified 2011 General Plan.

The General Plan 2014 Task Force shall:

- (1) Review and edit the voter-ratified 2001 General Plan.
- (2) Review and incorporate where appropriate the non-ratified 2011 General Plan Update.

(3) Review and incorporate other community input and resources, as necessary, to create a draft Scottsdale General Plan 2014.

(4) Work with the Planning Agency of the City of Scottsdale to host and attend community meetings for public input on the Scottsdale General Plan 2014.

(5) Deliver a recommended General Plan 2014 to the Planning Commission.

(6) Monitor progress and any changes to the recommended Scottsdale General Plan 2014 through the City Council adoption hearing(s).
