- 2) Promoting and supporting the needs of the tourism community, including, but not limited to, a focus on the practical implementation of major community attractions and capital projects.
- 3) Developing and implementing amenities which are incidental but critical to community-wide economic development (e.g., enhancement of the City trolley system).
