

## Judicial Appointments Advisory Board

**Description:** The Judicial Appointments Advisory Board (JAAB) makes advisory recommendations to the City Council regarding the appointment and reappointment of full-time City judges. The JAAB will use merit-based criteria to recommend the best-qualified people to become City judges and to advise the City Council about retaining City judges.

**Special Qualifications:** The seven-member JAAB will consist of two active judges, one representative from both the State Bar and the Scottsdale Bar Associations, and three citizens appointed by the City Council, who are not judges in any official capacity, nor retired judges, nor members of the State Bar of Arizona.

Per Ordinance No. 3254, the Council must appoint/reappoint members who are recommended from the Scottsdale Bar Association or the Arizona Superior Court.

The purpose of the Judicial Appointments Advisory Board is to recommend to the City Council the best-qualified persons to become full-time City judges, to evaluate the performance of incumbent full-time City judges, and to advise the City Council about retaining them in office.
