REGULAR MEETING AGENDA

1. FY 2021-2022 Funding Allocation (Informal Recommendations)

Irma Hollamby, Community Assistance Manager, and Diane Ethington, Community Assistance Grants Accountant, facilitated a discussion about preliminary funding recommendations for the Community Development Block Grant, HOME, Scottsdale Cares, General Funds, and Endowment.

Ms. Hollamby reiterated that because no General Funds dollars were made available, \$100,000 in SRPMIC grants have been applied to that category. She noted that the Human Services Commission will make its formal recommendations on March 25, 2021. City Council is scheduled to take action on CDBG and HOME awards on April 27, 2021 and Scottsdale Cares, General Funds, and Endowment on June 15, 2021. She reminded the Commission of the importance of applying funding consistent with the scoring of each agency's proposal. If awards are not consistent with the scoring, a valid justification must be given.

Discussion ensued and the Commission made tentative allocation recommendations for each agency as follows:
