

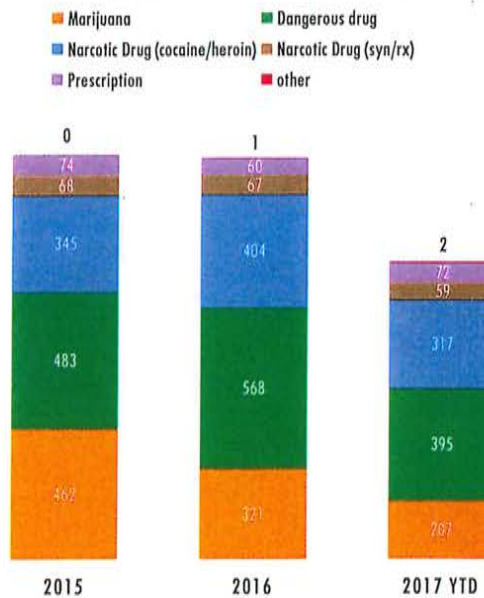

**Council Update**

**The impact of Opioids in Scottsdale**

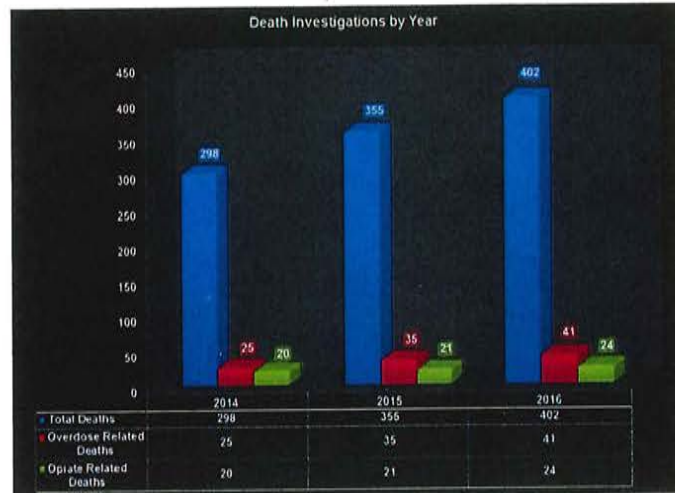
- Drug seizures and Arrests that have included drug charges indicate that there is more activity including dangerous drugs (methamphetamines, barbiturates, etc.) in Scottsdale, followed by Marijuana and then narcotic drugs (cocaine and heroin).
- Synthetic/Prescription Narcotic related arrests are ~5% of total drug related arrests over the last three years
- The SPD Violent Crimes Unit and DEA Task Force Group partnered with the DEA and Maricopa County Medical Examiner's Office to participate in the DEA Heroin Enforcement Action Team in March 2017

**SCOTTSDALE DRUG RELATED ARRESTS**



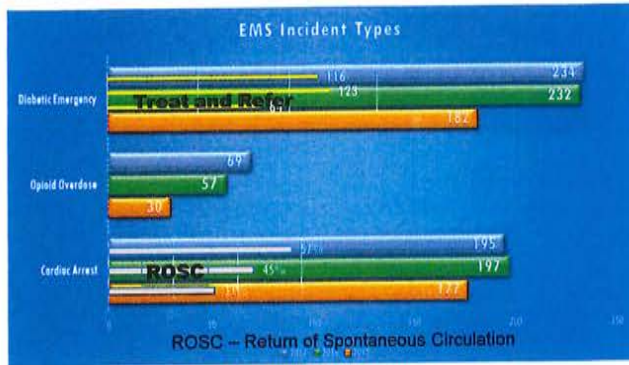
## Scottsdale Police Department Police Response to Opioid Related Deaths

- Per Medical Examiner Reports for death investigations, Opioid related deaths have increased in the last three years
- Opiate related deaths as a percentage of total drug related deaths has decreased over the last three years
- Police and Fire statistics can vary due to duplicate reports



## Scottsdale Police Department

- Arizona Revised Statute 36-2228 allows trained peace officers to administer naloxone (Narcan) to a person who is believed to be suffering from an opioid-related drug overdose
- The Arizona Peace Officer Standards Training (POST) Board has developed training with experts and POST physicians in coordination with the AZ Department of Health Services
- The City of Scottsdale (via Police Legal Advisor Luis Santaella) identified the gap in the authority for civilian law enforcement personnel in administering naloxone and worked with the State Department of Health Services to obtain an emergency order from the director of DHS that authorizes civilian law enforcement personnel state wide to administer naloxone to victims of an opioid overdose
- 316 police personnel have completed POST training and are authorized to use Narcan



Diabetes affects over 30 million Americans and accounts for 80,000 deaths annually at a cost of \$250 Billion.

The Fire Department's quick response to Hypoglycemia (low blood sugar) incidents leads to rapid treatment, and immediate reversal of life threatening complication.

More than 90 people a day die from opioid overdose. These preventable deaths can be limited by the rapid administration of Naloxone (Narcan) along with supportive airway, breathing, and circulatory support. Scottsdale Fire Department's paramedics have administered Naloxone for decades.

Every year more than 200,000 people suffer Cardiac Arrest (the sudden loss of circulation, breathing, and consciousness.) Rapid defibrillation, chest compressions, and drug therapy can minimize brain death and loss of life. Through extensive training, experience, and access to cutting edge technology, our paramedics have demonstrated consistently improved patient outcomes.

## Youth and Family Services

*The City of Scottsdale's Youth and Family Services works closely with the community to address the opioid issue by providing and supporting educational programming and referrals.*

**Examples include:**

- An intergovernmental agreement (IGA) with the Scottsdale Unified School District supporting substance use prevention.
- Referrals for families to community substance abuse support groups such as Parents of Addicted Love Ones (PALS) and Family Anonymous Recovery.
- Information and referral services to adolescent treatment programs.
- Educational YFS classes and sessions for youth on the dangers of substance use including a strong component on opioid and heroin prevention based on the 2016 Arizona Youth Survey (AYS) results. Results demonstrated an increase in opioid use among Scottsdale teens.



## Youth and Family Services

- Partnerships with community agencies, such as **not MY kid**, which provides education and navigation of help to parents, and **MASK** (Mother's Awareness of School Age Kids) a magazine that provides parents with information on substance use and current trends.
- Membership on the Phoenix Adverse Childhood Experiences Consortium for 8 years.
- YFS staff are registered to attend the October 19, 2017 Interfaith & Community Leader Breakfast: The Opioid Epidemic.
- Facilitation of the Multidisciplinary Team; a free education and resource meeting held for professionals working with vulnerable populations. Experts on opioid use and addiction are invited to present on current trends and use.



## Senior Services

***Individuals 55 and older make up the second highest number of deaths by Opioid overdose according to the Department of Health Services.***

- Senior Services Social Workers work with the client to seek help by encouraging in-patient behavioral health services.
- If they are a willing party the social worker will make arrangements to have client evaluated and transported to the identified mental health hospital or treatment facility.
- If client is an unwilling participant or in denial, social worker will reach out to family, physicians, City of Scottsdale Crisis Intervention Team, and other invested parties to seek support in getting client help.
- In partnership with Area Agency on Aging we will be offering two different health and wellness programs aimed at educating the community on healthy aging and the proper use of medication.



# Senior Services

***Scottsdale Senior Services collaborates with Area Agency on Aging to provide the following programs.***

- **Wellness Initiative for Senior Education (WISE):** The WISE Program is a wellness and prevention program targeting older adults, which is designed to help them celebrate healthy aging, make healthy lifestyle choices and avoid substance abuse. It provides valuable educational services to older adults on topics including medication misuse and management, stress management, depression, and substance abuse.
- **Mental Health First Aid:** Educates those who want to help someone experiencing a mental health or substance use-related crisis. In the Mental Health First Aid course, you learn risk factors and warning signs for mental health and addiction concerns, strategies for how to help someone in both crisis and non-crisis situations, and where to turn for help.



# PETITION

1. Citizen Petition against the Marshall Way Entry Feature (15-DR-2017), also known as the "Giant Metal Humping Rabbit."

I am petitioning that City Council and Staff not spend any more time and money on this unnecessary and wasteful project, and that any remaining funds that City Council budgeted for this project be spent on deteriorating infrastructure on and around the Bob Parks Horse Fountain directly north, in an effort to make Downtown Scottsdale attractive to tourists again. 
