ITEM NO. 28 – CARES ACT FUNDING

Mayor Lane: That completes our consent items. Thank you, Ms. Jagger. We will move on to our regular agenda item, and that is item 28 and that's CARES Act Funding and presenting on this is our city manager, Jim Thompson.

City Manager Jim Thompson: Before you this evening we have discussion and direction for funding for the use of federal CARES Act Fund and adoption resolution number 11870. I think in our last session, we were looking for further detail and analysis and in front of you this evening at least on the screen is the Scottsdale AZCares funding priority matrix. In your packet, attached is detail to each of these areas to add to the dollar amount so noted. Again, you see a slightly different format than you did originally. The other change that you would see on this is there is an amount stated for future COVID resurgence preparation of \$2 million.

We did set aside some additional funds in that area, just in case we see a continual rise as we have. As we all know, since the last time we met and discussed this matter, we have seen the number of cases in Arizona rise and so, again, just want to be prepared as we continue in this state of emergency.

Mayor Lane, City Manager Thompson, I apologize for interrupting. I have a hand raised by Councilwoman Klapp that I wanted to alert you to, as well as Councilwoman Whitehead.

Mayor Lane: Okay, Councilwoman Klapp.

Councilwoman Klapp: I hate to jump in here but when council woman Whitehead made her motion, she moved to accept consent items 1 through 28. We voted on that. We didn't vote to septum number 28 in her motion. We need to have a separate acceptance to add this to the agenda. Her motion was for items 1 through 27.

Mayor Lane: Are we saying we voted on 1 through 18, including -- 28 including our regular agenda item?

Councilwoman Klapp: No, I'm saying when she made a motion to add items to the agenda, as I understand it, unless I heard it wrong, I thought we only added item 27. Did I hear it incorrectly? I'm

sorry if I did.

Mayor Lane: I will ask maybe the city clerk if she could clarify how that went.

City Clerk Carolyn Jagger: Mayor, I recorded it, that it was to add -- to accept the agenda as presented, all of the items, which would have included the added items of 27 and 28. We have recorded that motion. Unless there's objections by any of the council, that's the way we're going to record the motion. Does that sound good?

Councilwoman Klapp: That sounds good to me. I must have misheard it.

City Clerk Carolyn Jagger: All right. Thank you.

Management Assistant Megan Lynn: And just to alert the Mayor, this is Megan we do have a hand raised by Councilwoman Whitehead and Councilwoman Littlefield.

Mayor Lane: Councilwoman Whitehead, if you want to go ahead with your comments.

Vice Mayor Whitehead: Actually there, I will un-raise it. I want to speak afterwards. Sorry. Let me unraise it.

Mayor Lane: Okay. Councilwoman Littlefield, would you like to speak at this time?

Councilwoman Littlefield: Thank you. I'm glad Councilwoman Klapp said that, I heard the same thing and I was going to suggest that we include 28 into the current regular agenda, just in case, and so there is no question that that has gone through the normal channels. Thank you.

Mayor Lane: All right. Very good then. Then Jim, do you want to go ahead and proceed or is there --

City Manager Jim Thompson: Yes, Mr. Mayor, if I may. Thank you. As we see in the framework itself, what's in front of you this evening on chart, each of those areas has been depicted in your attachments. So as an example, when we go through the homeless portion under citizens, the \$823,000, we give a complete explanation in that investment. And then we go to additional programs underneath that, the Day Relief Centers and the Community Bridges Programs and Gellert Health Partnership, the Scottsdale Works Program and the Street Outreach Program all are part of that portion. And then the seniors program, likewise, we go through all the different programs which include the home delivered meals, the conjugate meals, the adopt a senior, beat the heat programs, and likewise, for every one of the areas on the chart in front of you this evening. So we try to depict in greater detail where we will be placing those monies associated with these portions.

There are a few areas that are a little bit more open ended, as you go further in the chart. As an example, the future COVID resurgence that we just talked about, and then some of the amount under

the public safety for the existing programs and personnel in those programs that have been assigned to the emergency response in particular some of the PPE in some of those areas and some of the costs we inherently have incurred.

Just a quick explanation, how did we receive the CARES money. It was provided to the state, each city was then given the opportunity to submit, based on a formula that the state presented and the city of Scottsdale was eligible for \$29,628,014. How we came up with that number and the resources and how the state has determined that we must submit to comply to the CARES Act under state funding program, that they were in compliance with the federal program, was through our public safety, police and fire expenditures that would occur throughout the period of time for which the declaration was -- occurred in March of '19 through the end of this fiscal year, as well as the '20-21 fiscal year through December 30th of 2020. We calculated out our payroll expenses and forecasted expenses which in line met the \$29,628,014 to be eligible and we have received those funds.

So this evening, we are asking to ask for council's authorization to move forward and start spending those funds in these specific areas as outlined. Thank you, Mr. Mayor.

Mayor Lane: Thank you, Mr. Thompson. That completes your report and thank you very much for that. With that then, I will go ahead and ask each of the councilmembers one by one if they have questions. So, I will start with Vice Mayor Whitehead.

I think this looks like a program that's well thought out and I appreciate the work that's gone into it, and look forward to hearing about the individual items that are under each of these categories and getting more detail. Councilwoman Littlefield: Thank you, Mayor and I echo what the others have said. I think this has been well worked out, well thought out, well planned, and I look forward to hearing the additional details also. And I particularly would like to thank you, Jim Thompson, our city manager for all the time and work and effort that you have put into this. Thank you very much.

Mayor Lane: Thank you, Councilwoman Littlefield. Councilwoman Milhaven.

Councilwoman Milhaven: No, I have no questions and I would like to echo the thanks to the staff. Thank you.

Mayor Lane: Thank you, Councilwoman Milhaven. Councilman Phillips?

Councilman Phillips: Nothing further.

Mayor Lane: Thank you. I just have a couple of observations, Jim, that I would like to at least ask about. And one of them is that under the care for the vulnerable, the low-income assistance I'm presuming, I'm not sure what forms that came in, whether you mentioned that or not, but the program right underneath it, the utility assistance program, do they both have the same type of criteria, as far as not only what -- if the vulnerability is defined by low-income, which I'm sure that it could be, do we not have the same element of utility assistance, maybe covered in both of those numbers?

City Manager Jim Thompson: Yes, sir, there's some implication, the one is utility assistance that goes beyond the city. The other one is specific to the city's utilities bills for which we had a program in place, however, the demand of that program has gone up during this period of time with some of the impacts to individuals in our community. So the one above is specific in nature to all utilities. The one for the residential utility program is specific in nature to the municipal utility assistance program that we run.

Mayor Lane: Okay. Thank you for that. The other was an item listed in our documentation with regard to the Scottsdale Gallery Association. I didn't know whether or not this was not -- didn't equate, maybe to just business assistance, which would have maybe come in underneath the business assistance programs for businesses on a variety of things that are located in that category, under \$1.5 million or is the Scottsdale Gallery Association a not-for-profit with some other functions that would otherwise come into maybe some of the marketing programs that are talked about for Old Town? Is there some duplication there or maybe miscoding?

City Manager Jim Thompson: Mr. Mayor, there's two opportunities for that group. It's not specific in nature, because in the arts and cultures program for \$1.5 million, those monies will be a grant-based program, where they will actually have to provide for an application. It's one-time relief, additional

relief to organizations. There are some considerations if they are housed in city buildings, that they are currently funded by the city and/or other donor match qualifications. So if those things exist, they will rate higher, potentially under that programming.

And then again, under the critical and immediate critical business support initiative, there's multiple areas for which some of the galleries might be eligible, maybe the small business assistance program, maybe the support Scottsdale website, and maybe the community stakeholder engagement, or the good to go open business program, maybe the shop Scottsdale program, as well as a host of others, which would not be specific to the galleries but that district that has many, the outdoor dining license agreement offsets, the relief for the in lieu parking payments during business closure, the extending of building permits that would have expired during the pandemic and likewise. There's multiple programs under there. So the galleries of themselves and the merchants in the Old Town will have multiple areas in which to potentially apply for funding, specifically back to the Gallery Association, yes, they -- they could receive funding under both of those areas.

Mayor Lane: All right. Very good. I understand and this is some distinction between the functions within those two groups. So thank you for that. I have no further questions. I do not see any raised hands. So I'm presuming there are no further questions from the council.
