| Existing provision with minor updates | 7 | 7-1.103 | COUNTY SEWER SERVICE | Water resources provided clarification for sewer extensions outside the city's jurisdictional limits. |
| New provision | 7 | 7-1.400 | PUBLIC OR PRIVATE SEWER DESIGNATION | Water resources consolidated language, make consistent and coordinate with code. On-site SS lines to non-platted commercial shopping center developments must be privately owned, operated and maintained.
