Any signatures collected before the Statement of Interest is filed with the Clerk are invalid and may be subject to challenge. However, if a candidate collected signatures before August 27, 2019, and files a Statement of Interest with the City Clerk by January 2, 2020, the candidate's otherwise legally sufficient signatures are not subject to challenge on the basis of their collection before the filing date of the candidate's Statement of Interest.
