#### **RESOLUTION NO. 11833**

A RESOLUTION OF THE COUNCIL OF THE CITY OF SCOTTSDALE, MARICOPA COUNTY, ARIZONA, APPROVING THE RECOMMENDATIONS OF THE HUMAN SERVICES COMMISSION AND ALLOCATING FUNDING FROM THE GENERAL FUND FOR FISCAL YEAR 2020/2021 FOR HUMAN SERVICES PROGRAMS AND AUTHORIZING EXECUTION OF CONTRACTS.

WHEREAS, the City has included \$200,000 in the General Fund FY 2020/2021 budget for human services programs and activities;

WHEREAS, the Human Services Commission conducted a public process to solicit proposals and heard presentations by agencies seeking General Funds for human services programs and activities for Scottsdale residents;

WHEREAS, based upon the proposals and presentations, the Human Services Commission recommended that General Funds allocations be made to seven agencies in the amounts shown on Exhibit A to this Resolution; and

WHEREAS, the City Council believes that funding the agencies in the amounts shown on Exhibit A is appropriate and in the best interests of those Scottsdale residents needing human services programs and activities;

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Scottsdale, Arizona, as follows:

Section 1. The City Council hereby approves allocating funding from the General Fund to the non-profit agencies listed in and in the amounts shown in Exhibit A to this Resolution, which is incorporated herein by this reference, for programs and services provided during FY 2020/2021. Such allocations are subject to each agency's successful performance of its obligations under the contracts executed with the City. The City Council further approves the City entering into contracts with the identified non-profit agencies, to be effective July 1, 2020, subject to final negotiation of scopes of work.

Section 2. The Mayor is hereby authorized and directed to execute, on behalf of the City, contracts with the agencies for services and programs that exceed the current formal bid limit of \$25,000. These contracts shall substantially conform to the form attached as Exhibit B to this resolution, which is incorporated by this reference.

<u>Section 3.</u> The Assistant City Manager or his designee is hereby authorized to execute, on behalf of the City, contracts with the agencies for programs and services that do not exceed the formal bid limit.

### EXHIBIT A PROJECT DETAILS GENERAL FUNDS RECOMMENDED FOR FY 2020-2021 FUNDING

#### GENERAL FUNDS - \$200,000

#### Catholic Charities Community Services, Inc. — My Sister's Place \$40,000

7 victims of domestic violence will receive shelter (bed nights) and supportive services.

## Community Legal Services, Inc. — Strategic Legal Advocacy for Low-Income Scottsdale Residents- \$29,925

Community Legal Services will provide approximately 691 hours of legal assistance to 56 Scottsdale residents to assist in resolving civil legal problems.

## Duet: Partners in Health and Aging — Promoting Aging in Place in Scottsdale through Transportation and In-Home Services \$25,000

Approximately 140 elderly and disabled Scottsdale residents will receive transportation and inhome services through this program.

### Family Promise Greater Phoenix — Emergency Shelter Program – Transportation \$40,000

Through the Emergency Shelter Program, 350 homeless families will be provided a total of 14,000 bed nights and will receive safe shelter, food, basic needs, clothing, childcare, transportation, case management, cash flow training, employment and housing assistance.

# Jewish Family & Children's Service (JFCS) — JFCS Older Adults In-Home Program - \$25,075

Through the Older Adults In-Home Program, 75 elderly and disabled residents will be provided a total of 843 hours of in-home assessment, case management, counseling advocacy and referral to appropriate resources throughout Maricopa County.

## Scottsdale Community Partners (SCP) – Brown Bag Food Program, Senior Emergency Rental Assistance, Via Linda Senior Center Congregate Meals \$40,000

350 elderly and disabled Scottsdale residents will receive with a once a month staples bag and 2 monthly supplemental bags, including perishable items such as fresh produce as well as canned goods and rental assistance.
