The backflow prevention assembly testers listed below hold a Scottsdale business license and have demonstrated required regulatory (Arizona Department of Environmental Quality) certification. Unless exempt, a party engaging in the business of construction services must hold a contractor’s license in good standing as provided in A.R.S. §§ 32-1101, et seq. These testers have provided to the city an Arizona Registrar of Contractors license number. The city does not endorse any private, backflow prevention assembly testers and a decision to select a tester from this list is the customer’s responsibility. This list is updated and sorted randomly every quarter.
