INTRODUCTION

To the Voters of the City of Scottsdale:

This pamphlet provides you with information regarding the City of Scottsdale's August 2, 2022 Primary Election to elect three Councilmembers. A General Election, if necessary, shall be held on Tuesday, November 8, 2022, to fill any elected offices that remain unfilled after the Primary Election. To be elected at the Primary Election, a candidate must receive a majority of all of the legal votes cast for that candidate's race.

This pamphlet contains general voting information regarding early voting and identification at the polls. Also included in the pamphlet are statements prepared and submitted by each of the candidates for this election. Candidate statements represent the opinions of the authors and have not been edited or checked for accuracy of content. The order of the candidate statements was determined through a drawing.

All qualified electors of the City, regardless of party registration, may vote for three council candidates. A qualified elector of the City is defined as a person, eighteen years or older, whose name appears on Maricopa County's list of registered voters in a City of Scottsdale precinct 29 days prior to the date of election. To vote in the City's August 2, 2022 Primary Election, Scottsdale residents must be registered to vote by Tuesday, July 5, 2022.

Voters who are not affiliated with any political party and who are on the Active Early Voting List (previously known as the Permanent Early Voting List) will not automatically receive a ballot for Scottsdale's August 2, 2022 Primary Election. Voters who are not affiliated with a political party have the option of requesting a political party ballot of their choice or a Scottsdale-only ballot. These voters must notify Maricopa County Elections of their selection to receive a mail-in ballot for the August 2, 2022 Primary Election by returning a postcard that was mailed by Maricopa County the week of May 2, 2022, online at [BeBallotReady.Vote](https://www.maricopa.gov/BeBallotReadyVote), or by calling 602-506-1511.



IMPORTANT VOTING INFORMATION

AUGUST 2, 2022 PRIMARY ELECTION

The City of Scottsdale will hold a Primary Election on August 2, 2022 to elect three Councilmembers. A General Election, if necessary, shall be held on Tuesday, November 8, 2022, to fill any elected offices that remain unfilled after the Primary Election. To be elected at the Primary Election, a candidate must receive a majority of all of the legal votes cast for that candidate's race.

Voters who are not affiliated with any political party and who are on the Active Early Voting List (previously known as the Permanent Early Voting List) will not automatically receive a ballot for Scottsdale's August 2, 2022 Primary Election. Voters who are not affiliated with a political party have the option of requesting a political party ballot of their choice or a Scottsdale-only ballot. These voters must notify Maricopa County Elections of their selection to receive a mail-in ballot for the August 2, 2022 Primary Election by returning a postcard that was mailed by Maricopa County the week of May 2, 2022, online at [BeBallotReady.Vote](https://www.maricopa.vote), or by calling 602-506-1511.

QUALIFICATIONS TO VOTE

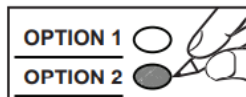
To vote in this election, you must be registered to vote within the boundaries of Scottsdale before midnight on Tuesday, July 5, 2022. You may check your registration status, track your ballot and more online at [BeBallotReady.Vote](https://www.maricopa.vote) or by calling the Maricopa County Elections Department at 602-506-1511.

REQUESTING BALLOTS BE SENT TO AN ALTERNATE (TEMPORARY) ADDRESS

The U.S. Postal Service cannot forward ballots to another address. If you will be out of town and would like to receive a ballot for Scottsdale's City Council Election at a temporary address, please contact the Maricopa County Elections Department by calling 602-506-1511.

BALLOT DESIGN

Ballots were recently updated to have fill-in ovals instead of arrows.



RETURNING VOTED EARLY BALLOTS

A voted early ballot must be returned in the ballot affidavit envelope that was provided with the ballot. Make sure to sign, date, and provide a current phone number on your affidavit envelope. To be valid and counted, voted ballots must be received by Maricopa County Elections no later than 7:00 p.m. on Election Day, Tuesday, August 2, 2022.

If you return your voted ballot by mail, be sure to allow sufficient time for delivery. It is recommended to mail your ballot at least 7 days (Tuesday, July 26, 2022) before Election Day. In addition to mailing, voters may drop off voted ballots at any of the voting locations or ballot drop boxes listed on page 4.

If an early ballot is destroyed, lost, spoiled, or not received, a replacement ballot may be requested by phone at 602-506-1511 or online at [Maricopa.Vote](https://www.maricopa.vote) before 5:00 p.m. on Friday, July 22, 2022. A replacement ballot also may be obtained at any of the voting locations found on page 4 during the stated hours of operation.

IMPORTANT VOTING INFORMATION

HOW CAN I CHECK THE STATUS OF MY BALLOT?

Information about the status of your ballot is available online at [BeBallotReady.Vote](#), where you can obtain detailed information, such as the date your ballot was mailed, received, or processed for tabulation.

To check your ballot status, you will need to provide your date of birth, last name, and home address number. Additionally, you will need to provide one of the following pieces of information: last four digits of your social security number; driver license number; voter identification number; or state non-operating identification license number. This information is required to positively identify you as the voter and the information you enter must match the information on your voter registration record.

You can also sign up for ballot status text alerts by texting "JOIN" to 628-683.

VOTING LOCATIONS

In-person voting, using Ballot On Demand (vote anywhere) technology, will be held at various locations throughout Maricopa County. You can request a replacement ballot, vote in person, or drop off your voted early ballot at the following Scottsdale locations starting Wednesday, July 6, 2022:

Other locations in Maricopa County can be found by calling 480-312-2412 or online at [Locations.Maricopa.Vote](#). **All voting locations will be open on Election Day, Tuesday, August 2, 2022, starting at 6:00 a.m. until 7:00 p.m.** Any qualified voter who is in the line of waiting voters at 7:00 p.m. shall be allowed to prepare and cast their ballot. Your Candidate Information Pamphlet may be brought into the voting location and taken into the voting booth.

VOTING ASSISTANCE

You may request a Braille or large print ballot by calling 602-506-1511. Voters who need assistance due to a confining illness or disability may request Special Election Board assistance by calling 602-506-1511 or emailing SEB@risc.maricopa.gov by 5:00 p.m. on Friday, July 22, 2022. Please provide your full name, residence address, contact information, and date of birth for verification purposes. Accessible voting devices are available at all voting locations, as well as curbside voting for voters who are unable to leave their vehicle due to physical limitations.

KEY ELECTION DATES

Date of Election **Tuesday, August 2, 2022**

In this Primary Election, City of Scottsdale voters will elect three Councilmembers. A General Election, if necessary, shall be held on Tuesday, November 8, 2022, to fill any elected offices that remain unfilled after the Primary Election.

Military and Overseas Ballots Mailed **Saturday, June 18, 2022**

The Uniformed and Overseas Citizens Absentee Voting Act (UOCAVA) requires that ballots be sent to UOCAVA voters (active members of the Uniformed Services) at least 45 days before an election.

Last Day to Register to Vote **Tuesday, July 5, 2022**

Your written or verbal request for voting assistance, due to a confining illness or disability, must be received by the Maricopa County Elections Department by 5:00 p.m. Please call 602-506-1511 or email SEB@risc.maricopa.gov for more information and include your full name, residence address, contact information, and date of birth for verification purposes.

Last Day to Request a Replacement Ballot **Friday, July 22, 2022**

If you do not receive your ballot in the mail or if you need to request a replacement ballot, call 602-506-1511 or go online at [Request.Maricopa.Vote](https://www.maricopa.gov/Request.Maricopa.Vote) through 5:00 p.m. on Friday, July 22, 2022. After Friday, July 22, 2022, you may request a replacement ballot in person at one of the voting locations listed on page 4.

Recommended Date to Mail Completed Ballots **Tuesday, July 26, 2022**

If you return your voted ballot by mail, be sure to allow sufficient time for delivery. It is recommended you mail your ballot at least 7 days before Election Day.

Ballot Must Be Received By **7:00 p.m., Tuesday, August 2, 2022**

For your ballot to be valid and counted, your voted ballot and signed affidavit must be received (POSTMARKS DO NOT COUNT) by the Maricopa County Elections Department by 7:00 p.m. on Election Day, Tuesday, August 2, 2022. You may also deposit your ballot and affidavit at any voting location or drop box location before the 7:00 p.m. deadline.

Election Results **8:00 p.m., Tuesday, August 2, 2022**

Election results will be released shortly after 8:00 p.m. To view election results, please visit [Scottsdale.Vote](https://www.maricopa.gov/Scottsdale.Vote).

VOTER IDENTIFICATION AT THE VOTING LOCATIONS

When voting at a voting location, voters shall announce their name and place of residence to the election official and present one form of identification from List 1 OR two different forms of identification from Lists 2 or 3. Please visit [GetID.Maricopa.Vote](#) for more information.

LIST 1 – Acceptable forms of ID with voter’s photograph, name, and address. The address must match the precinct register (1 required):

- Valid Arizona driver license
- Valid Arizona non-operating identification license
- Tribal enrollment card or other form of tribal identification
- Valid United States federal, state, or local government issued identification

An identification is “valid” unless it can be determined on its face that it has expired.

LIST 2 – Acceptable forms of ID (no photo) with voter’s name and address. The address must match the precinct register (2 required):

- Utility bill of the elector dated within 90 days of the election (may be electric, gas, water, solid waste, sewer, telephone, cellular phone, or cable television)
- Bank or credit union statement dated within 90 days of the election
- Valid Arizona vehicle registration
- Indian census card
- Property tax statement of the elector’s residence
- Tribal enrollment card or other form of tribal identification
- Arizona vehicle insurance card
- Recorder’s Certificate
- Valid United States federal, state, or local government issued identification, including a voter registration card issued by the County Recorder
- Any mailing to the elector marked “Official Election Material”

LIST 3 – Acceptable forms of ID, one with photo, one without (2 required):

- Any valid photo identification from List 1, with an address that does not match the precinct register, accompanied by one valid item from List 2
- United States passport without address and one valid item from List 2
- United States military identification and one valid item from List 2

PROVISIONAL BALLOT

If the voter does not have sufficient identification at the voting location, the voter will be issued a provisional ballot. To be a valid and counted ballot, sufficient identification must be presented to the Scottsdale City Clerk or the Maricopa County Recorder before 5:00 p.m. on Tuesday, August 9, 2022.

- Restoring the "Scottsdale Premium" for development by reducing heights and density, adding open spaces, stipulating water and energy conservation, and requiring community investment and public support.
- Increasing investments for parks, open space, paths, and trees in the southern part of Scottsdale.
- Protecting tax dollars with improved contracts, negotiated community investments from developers, and by protecting utility energy efficiency rebates.
- Winning at the ballot box to fund infrastructure and ratify an updated General Plan.
- Preventing a road through the McDowell Sonoran Preserve and restoring land acquisition as a top priority for Preserve dollars.
- Protecting seniors and other vulnerable populations by volunteering, protecting program funding, boosting Scottsdale Cares donations in 2020, and protecting free access to City amenities.
- Strengthening ordinances and increasing resources to protect neighborhoods from short term rentals.
- Protecting Scottsdale's equestrian lifestyle and heritage by restoring equestrian easements, protecting equestrian zoning, and voting to keep Scottsdale's equestrian flag.
- Restoring Scottsdale's green leadership with state-of-the-art water conservation, policies to reduce urban heat and increase tree coverage, and expanded solar power generation and EV infrastructure.

Much has been accomplished and I will continue to ensure that City priorities protect tomorrow's prosperity. For these reasons, I am enthusiastically seeking your support for re-election.
