These clinics are most likely to provide you the best expedited injury care. Their physicians and physician assistants have the City's return to work forms, know the city's pharmacy formulary, and know to get pre-authorization for specialist treatment or MRIs generally same day. You do have a choice in who provides your injury treatment, however, please be aware that not all doctors will treat workers' compensation injury cases. Before using a physician or specialist of your choice for treatment, make sure they accept workers' compensation cases. If you have no initial preference, we recommend one of these clinics as they specialize in workers' compensation injury treatment, they have the work release forms that you will need to provide to your supervisor, they will set up referral appointments for you, and they know how to bill the city for the services. If you are too injured for one of the clinic doctors; or need treatment after the clinics are closed; please proceed to the emergency room. If the physician you treat with prescribed you medication for your work-related injury or illness you can fill your prescription immediately.
