

# **Event Directional Banner Guidelines**

The City of Scottsdale maintains the streetlight vertical banner poles and horizontal banner light poles and has sole jurisdiction over use of these poles and prescribed approved uses, size, content of banners and requirements. The use of the street light poles is expressly limited to the uses authorized and is not open to the public at large.

The primary purpose of Scottsdale's Event Directional Banner program policy is to allow the special events, promotions, and City departments the opportunity to support their events or promotions. When applying to display horizontal or vertical directional street banners, certain requirements will need to be satisfied by the applicant. These requirements are as follows:

#### **ELIGIBILITY**

#### **Authorized Users**

The following users are authorized to apply for banner use, with the following priority (when applications are received for same timeframe):

- City of Scottsdale owned/produced events with scheduled annual event blackout dates.
  - Scottsdazzle
  - · Western Week
  - June Days
  - · Canal Convergence
- Events funded by the city's event funding programs.
- City of Scottsdale Departments to promote major programs.
- Events not funded by the city that meet at least one of the city's tourism drivers; art and culture, culinary, golf, sports, and recreation or western.
- Non-profit organizations providing promotional activities consistent with the city's specified tourism drivers.

# Prohibited Users/Uses:

- No general commercial use.
- No use by individuals.
- No political advocacy or religious messages.

#### Application for Use

- Please call 480-312-7177 or email <u>Tourismandevents@Scottsdaleaz.gov</u> to verify requested banner dates are available <u>before</u> applying.
- Banner applications may be submitted no sooner than six (6) months prior to the date of the event and must be submitted a minimum of 60 days prior to the event.
- The maximum period horizontal or vertical banners can be displayed is 14 consecutive days. (Exceptions may be made if there is efficiency of installation/removal of banners with consecutive events)
- The banners must contain the event title, date, and location.
- Banner designs may not change once approved.

### Charges for Use

- No charge to city departments for city use or for city owned/produced events.
- An application review fee of \$90 per application.
- Horizontal Banner Fee of \$150 per banner.
- Vertical Banner Fee of \$25 per banner.
- Payment must be received before banners are hung.

#### Applications Approval Process

Applications will be reviewed in the order that they are received. If event dates coincide, efforts will be made to place banners for multiple qualified events. A banner mock-up must be submitted and approved before installation. Banner designs may not change once approved.

# <u>Application Denial Process</u>

Shall an application be denied; an appeal may be made to the City Manager within 10 calendar days of the date of the decision. The appeal shall include the specific reasons for the appeal and any supporting documents. The City Manager shall decide on the appeal within 10 calendar days of receiving the appeal. After considering the appeal, the City Manager may uphold, reverse or modify the decision.

## **LOCATIONS & QUANTITIES:**

Old Town Horizontal Banners – 2 locations

- Scottsdale Rd. at Rancho Vista Drive
- Scottsdale Rd. at Earll Drive

Vertical Banners – 194 locations; 78 in North Scottsdale and 116 in Old Town

- Frank Lloyd Wright Blvd. (78)
  - Scottsdale Rd. to the west side of the west frontage road Loop 101
- Old Town Couplets (Total: 116)

Drinkwater from Scottsdale Rd to Earll (47)

Goldwater from Scottsdale Rd to Osborn (69)

#### Banner Drop-off Requirements

- Banners and their production are the sole responsibility of the event producer.
- Delivery must be made no later than 3 business days prior to the scheduled installation.
- If the banner is not delivered 3 days prior, it may be hung at the contracted installer's discretion.
- Banners must be picked up no later than 30 days following removal.
- The City of Scottsdale and contracted installers are not responsible for storing banners or their condition if damaged while being installed, during the display, or while being taken down.
- NOTE: If requesting all 194 banner placements, it may take 2 nights to complete the installation.
